

CASH BACK | TERMS AND CONDITIONS

Spend \$25, Get \$10 on the purchase of any Jamieson products.

Complete the following steps to claim your cash back rebate:

1. Spend \$25 or more (after application of any discounts or coupons, before taxes) at any Canadian retailer or online on any Jamieson products in **one (1) transaction** between July 1st, 2026, at 12:00:00 AM EST to September 30th, 2026, at 11:59:59PM EST.
2. Visit Spend25Get10withJamieson.ca to redeem offer. Receipts must be submitted no later than September 30th, 2026, at 11:59:59 pm EST **OR** while supplies last. A maximum of 3,000 cash back rebates are available, whichever occurs first.
3. Please upload a picture of the full receipt (jpg, jpeg, png or pdf file types) with all four corners and without any folds, shadows, or obstructions. The use of 1 receipt image is preferred to speed up processing, but multiple photos can be uploaded if the receipt cannot fit within a single photo. Receipt must clearly show the retailer's name, date, time, location, participating product(s) purchased, any coupons or discounts received, and amount paid. All participating purchases must appear on the same receipt to be eligible. Illegible, altered, or incomplete receipts will be rejected. Duplicate submissions are not permitted. **Screenshots from retailer apps are not accepted.**

For online purchases (including same-day deliveries), orders must be shipped, picked up or delivered before being eligible for cash back rebates. After shipment, pickup or delivery, submit the final retailer's e-mail confirmation (pickup, delivery or shipping record) or invoice, and save it as a PDF. Ensure all pages are included. The document must show your email address, name, delivery/contact address, retailer name, order number, shipment number, pickup location or delivery address, product details (including participating products & UPC codes or article numbers), unit price, subtotal, total, discounts, taxes, and payment method - all matching the Cash Back Request Form.

Limit: One (1) cash back rebate per sales receipt, regardless of spend level. Each eligible receipt must be uploaded individually. Each receipt may only be used once. Limit of one (1) cash back rebate per person, household, and/or email address during the Offer Period.

4. After clicking "REQUEST MY CASH BACK", you will receive a confirmation email. If a cheque is preferred over an Interac e-transfer, the participant will have 48 hours after receipt of the confirmation email to request a payment by cheque. Requests made about this period may not be accommodated. It is the responsibility of the participant to check his/her e-mail account for his/her e-mail including (but not limited to) his/her inbox, spam or junk folders.
5. Once the request is processed and approved, an Interac e-transfer for \$10 will be sent to the email address provided in the Cash Back Request Form within approximately 2-4 weeks. Alternatively, a reason why your request could not be processed at this time will be provided. Interac e-transfers are sent only to the email address provided on the Cash Back Request Form. Participants must provide a valid email they can use to accept e-transfers. Email addresses cannot be changed after submitting the form.
